## RULES ON REGISTRATION OF A NEW LITTER

1. This application must be submitted to the MKA within **ONE (1) CALENDER Month** from the birth of the litter, failing which a surcharge will be levied.
2. The late surcharge will be chargeable as follows, if the registration is submitted :
  - a) more than 1 month but not later than 2 months from the date of birth of litter: **RM106.00** per litter
  - b) more than 2 months but not later than 4 months from the date of birth of litter: **RM318.00** per litter
  - c) more than 4 months but not later than 6 months from the date of birth of litter: **RM530.00** per litter**An application made more than 6 months after the birth of the litter shall NOT be accepted.**
3. The applicant shall be responsible to ensure all the necessary details overleaf are completed accurately, truthfully and submitted together with the necessary fees for approval. An Application shall include Two (2) colour photographs (preferably taken after the puppies are 14 days old. Photographs of the puppies **MUST** be taken before they are 30 days old), of the following :
  - a. puppies in a group together – number of puppies must be clearly visible.
  - b. puppies nursing from Dam – number of puppies must be clearly visible.
4. The MKA shall not be responsible for any loss or damage of Pedigree Certificates sent by ordinary or registered post or courier services.
5. The MKA reserves the absolute right to inspect all litters, regardless of the number of whelps in each litter. An inspection fee of **RM53.00** will apply and has to be paid by the applicant.
6. The MKA shall not be responsible to refund any or all fees paid by the applicant for the withdrawal of an application.
7. The MKA shall only issue Microchip(s) to breeders after the Committee has approved an application together with the photographs or after a litter inspection has been carried out and approved.
8. Incomplete, illegible, incorrect or false declarations or misrepresentations provided overleaf may result in refusal to register the application. False declarations, misrepresentations and/or dishonest statements shall be regarded as a serious offence for which an applicant may be liable to prosecution or disciplinary action in the absolute opinion of the MKA.
9. If the application is refused for any reason, a processing fee of **RM30** will be charged and the balance of payment will be refunded. If a full refund of all fees paid for a Registration is sought due to death of all the puppies in the litter, a processing fee of **RM50** will be charged and the balance refunded.
10. On approval, the MKA will return three (3) copies of Form 2 to the breeder together with the required number of microchips.
11. The applicant shall be responsible to ensure that the microchip(s) is/are implanted by a certified veterinarian and obtain a certification from the relevant veterinarian that the implantation had been carried out successfully on Form 2, and to return one copy of Form 2 to the MKA for processing. Note that the issuance of microchip(s) shall not imply that the MKA shall issues Certified Pedigree.
12. The Applicant shall be fully responsible to witness; and shall sign and acknowledge; that the microchips have been implanted into all the puppies by the veterinarian. Any microchip(s) not implanted due to death of puppy shall be returned to the MKA. Any Failure by the applicant to comply with all the rules and requirements stated above shall result in the pedigree certificates not being issued.
13. If the MKA does not receive the certification of veterinarian form within six (6) months from the date of issue of microchip(s), the application shall be rejected without any refund.
14. Only the pick of litter can carry the Affix of the owner of the Stud Dog as a Suffix and in no other fashion. There shall be an additional fee of RM26.50 for every such registration.
15. The applicant shall state overleaf if he/she agrees to publishing litter details & information (name, state of residence and contact phone number only) on the MKA website. Failure to do so shall result in non publication of such details and information by the MKA.

**An Incomplete application, application without correct and full payment or application submitted without any photographs, incomplete number of photographs or inaccurate photographs as required in Point 3 above, shall be rejected by the MKA. Errors or mistakes on mating dates shall also be regarded as serious and may result in a refusal by the MKA to register the litter.**

### **AFFIX OF BREEDER (KENNEL NAME)**

If the breeder does not have an Affix (KENNEL NAME), He/She must apply for an Affix, either before or at the time of the registration of their first litter.
