1. This certificate must be submitted to the Malaysian Kennel Association within twenty eight (28) days of the Mating taking place. Late submissions shall not be accepted. Errors or Mistakes on or related to the Mating Date(s) shall render this certificate null and void.
2. Application for Registration of Litter (Form 2) must be submitted with full and complete details within one (1) month from the date of birth of the Litter.

RULES ON MATING CERTIFICATE

1. In the case of dogs or dams that are co-owned, all co-owners must sign this Mating form, unless there is a letter of authorization given by the co-owners.
2. Kindly ensure that the information given overleaf is correct, legible and complete. Incomplete, illegible or incorrect information may result in delay or refusal to register a litter of puppies by the MKA. Errors or Mistakes on Mating Dates shall be regarded as serious and may result in refusal to register a litter of puppies by the MKA.
3. The applicant must be the official owner of the Dam at the time of submission of the Mating Certificate, or alternatively has an application for transfer with MKA.
4. The MKA will NOT accept the Mating Certificate of an imported dog that has not been issued with a Certified Pedigree by the MKA, unless the ORIGINAL EXPORT PEDIGREE and the necessary documentation have been submitted with the MKA and are pending re-registration. Dams "Imported in Whelp" are excluded from this.
5. The information given overleaf cannot be altered once this certificate is submitted to the MKA.
6. A photocopy of the Stud dog's MKA pedigree, signed by the current owner must accompany this Mating Certificate.
7. Faxed or emailed copies of this certificate are acceptable. It is the responsibility of the applicant to check with MKA that the fax or email has been received. The MKA shall not be responsible for any faxed or emailed copy that has not been received. The Original copy of this Mating Certificate must be submitted to MKA before or upon the application to register the litter being submitted, in the case that you are not the Registered Owner/Co-owner of both the Sire and Dam.
8. MKA shall not be responsible for any loss through ordinary or registered post or courier services.
9. A separate certificate is to be used by owners bringing Dams 'Imported in Whelp' where the country of origin does not have a mating certificate. Please refer to MKA Form 1B.

The MKA reserves the absolute and unequivocal right to reject a Mating Certificate that does not comply with ALL the rules and requirements stated above.
