The application for a Single Microchip by owners of registered pure bred dogs is only applicable in the following two circumstances :

MKA Registered Dogs:

- Only the registered owner of the dog may apply for a replacement microchip where a dog has previously been microchipped and the microchip subsequently fails to function.
- Please include with this application : 1. A letter stating the reasons for your application; 2. The MKA Original Certificate Pedigree of the dog; 3. A letter from the certified veterinarian stating that the former microchip can no longer be detected by the use of a microchip scanner. The MKA reserves the right to request for an X-ray showing the malfunctioned chip in the dog.

Imported Dogs Registered overseas:

- MKA members may apply to microchip an imported dog which has been previously microchipped and the microchip subsequently fails to function OR the original microchip is not ISO compatible. Applicants have to provide: 1. A letter stating the reasons for your application; 2. A copy of the previous microchip certificate or proof that the dog was microchipped (Export Pedigree/ Pedigree Cert). The MKA reserves the right to request for an X-ray showing the malfunctioned chip in the dog.
- If a dog has never been microchipped applicants must enclose the original copy of the Overseas Certified Pedigree.
