The following documents **must be submitted** with this application, within the stipulated time frame\*\*\* :

1. **Original Certified Export Pedigree issued by the Kennel Club of the country of origin.\*\***  
(Certified Export Pedigree must show the applicant as the registered owner)
2. **Airwaybill**
3. **Import Permit**
4. **Quarantine Certificate (Only required for dogs imported from countries where quarantine is required.)**

**The Original Export Pedigree must be submitted within 6 months from the original date of application, or the application will be rendered Null and Void and a fresh application be made. There shall be no refund of application fees.**

\*\*In cases where the application for Original Export Pedigree has already been submitted with the country of origin, a photocopy of the Certified Pedigree OR any document(s) that indicate the Registered Name and overseas registration number of the imported dog, must be submitted with this application. Otherwise, the application will not be accepted.

\*\*\*Any applications made after TWELVE (12) months of the arrival of the dog into Malaysia, will not be considered.
