I/We, the undersigned being the applicant(s), wish to apply for the Registration of an Affix from the names given below, subject to the Rules and Regulations of the Malaysian Kennel Association. I/We also understand and agree that the approval of the name, is subject to the approval of the Central Committee of the Malaysian Kennel Association & the FCI, who have sole discretion over approval of the name and who are not obliged to give any reason for the rejection of any names applied for.

Please provide up to **FOUR (4)** preferred kennel names, with a compulsory minimum of two (2) options. The kennel name can consist of word or numerals and may be a maximum of two words (excluding the use of the word MYS or Malaysia), with the only permitted punctuation being a hyphen or apostrophe. As the MKA has a limit on the number of letters allowed for the registered name of a puppy, we suggest choosing an Affix that is not more than 15 letters. Every approved Kennel Name will have to pay an MKA Renewal Fee every three (3) years, from the date of approval.

## RULES GOVERNING THE REGISTRATION OF AN AFFIX (KENNEL NAME)

- 1. The object of registration of an Affix is to secure the exclusive right to the use of a word which will facilitate the selection of names acceptable for registration purposes and serve to distinguish animals which have been bred and owned by a particular individual or kennel. This application includes Registration of your Kennel Name with the FCI. Once registered and approved by the MKA and FCI, that name will belong to you globally and is then subject to the MKA payment of a Renewal Fee every three (3) years, from the date of Approval.
- 2. Use of an Affix:
  - (a) May **only** be used as a Prefix, that is to say, as the first word in the name of dog where the Grantee of the Affix is the breeder of the dog.
  - (b) May only be used as a Suffix, that is to say, as the last word in the name of a dog (including, at the discretion of the Grantee, the use of the world 'OF', 'BY', 'AT', 'WITH' or 'FOR' immediately before such Suffix), where:
    - (i) The Grantee of the Affix imported the dog and the dog is registered within the jurisdiction for the first time.
    - (ii) In the case of the Grantee being the owner of the Stud Dog taking the "Pick of the Litter" and upon obtaining a written consent from the breeder of the litter.
    - (iii) The Grantee of the Affix is the breeder of both parents of the dog and the dog is the first transferred to such Grantee.
  - (c) Such usage as in the preceding paragraphs may only be allowed insofar as the name of the dog does not exceed **40** letters.
- 3. Affixes may be registered in the names of two or more persons. An Affix granted in the name of a single owner can be transferred into the name of partnership. An Affix in the name of partnership can, with the consent of all the partners, be transferred in the sole ownership of any one of its partners. In cases of death, or of the desire of the owner to transfer an affix into the name of a close relative, consideration will always be given to a request to transfer, if the reasons for the request are fully explained to the Association.
- 4. Affixes cannot be used as part of a name for registration purposes by any person other than the owner of the Affix.
- 5. No Affix, registered with any MKA recognized Kennel Clubs or Canine Club or Association with whom the MKA has reciprocal arrangements, will be granted, unless the applicant can prove by the production of written evidence that such Affix is already registered in his or her name with the overseas club in question.
- 6. An Affix shall consist of word or numerals and may be hyphenated or use an apostrophe.
- 7. Affixes should preferably be 'made up' words, but may be name of houses, landed property, or villages belonging to or connected with the applicant. The names of Countries, States, Towns or other well know places or persons, titles, single letters or numbers (in figures) objectives or nouns appropriate to the name of a dog will only be granted at the discretion of the MKA.
  - (a) The MKA at its discretion may allow the use of the word 'House' or 'Kennel' in a foreign language as a word to be appended after a Prefix upon receipt of written application from the Breeder under clause 2 (a) above, even if such word is already part of the Kennel name of another MKA member.
  - (b) The MKA at its discretion may allow the use of the word 'OF', 'BY', 'AT' 'WITH' or 'FOR' in a foreign language as part of the suffix per written request received from the Grantee even if such word is already part of the Kennel name of another MKA member.
  - (c) If you are applying for an FCI Kennel Name using a current registered MKA Kennel Name, in case your current Kennel Name is already registered with the FCI by someone else, you can still use your existing Kennel Name by adding the letters **MYS** or the word **Malaysia** at the end of your current registered MKA Kennel Name. We recommend using the word MYS, which is shorter and won't restrict the number of allowed letters you can use for a registered name. For example –

Current name – Gemilang Kennels

- New FCI name Gemilang Kennels MYS OR Gemilang Kennels Malaysia
- (d) If you are applying for a new Kennel Name, we also recommend using the letters MYS at the end of your selected Kennel Name to distinguish it as coming from Malaysia.
- 8. The committee is in no way bound to disclose their decisions regarding the granting of Affixes.
