**DANCES WITH DOGS (DWD)**

The Central Committee of the MKA is keen to promote the canine sport of **Dances with Dogs (DWD)** and has sanctioned the first Dances With Dog competition in Malaysia which will be organized by Pet-N-You on 4<sup>th</sup> & 5<sup>th</sup> of June 2011.

In line with promoting the sport of DWD, the Central Committee has decided to implement a local MKA DWD Judges Training Program.

The MKA is working together with one of Australia's leading DWD judges and trainers, Mrs. Barbara Murfet who will be judging our first DWD competition and who will then conduct the first of our Judges Training Program Seminar and Entrance Examination for the sport of DWD on 2<sup>nd</sup>, 3<sup>rd</sup> & 6<sup>th</sup> June 2011. (Please see overleaf for the full program.)

This Judges Training program is open to MKA members only. Those interested in enrolling for the MKA DWD Judges Training program **must** meet **at least one** of the following criteria stated below:

1. Currently an MKA Obedience or Agility Judge.
2. Any person who has trained and taken part with his/her dog in an MKA recognized Obedience trials and achieved a qualification at Intermediate level.
3. Any person who has trained and taken part with his/her dog in MKA recognized Agility trial and achieved qualification at Agility Novice Class.

There is no charge for this initial Entrance examination and qualification, but there will be a charge of RM150 for the subsequent examination and once fully qualified, a yearly renewable MKA Judges Fee of RM50.
